**ORDINANCE 2105**

**AN ORDINANCE OF THE CITY OF SNOHOMISH, WASHINGTON  
AMENDING SNOHOMISH MUNICIPAL CODE SECTION 2.90.010  
RELATING TO THE DEFINITION OF “OFFICIALS AND EMPLOYEES”  
AND “VOLUNTEERS” FOR PURPOSES OF LEGAL REPRESENTATION.**

**WHEREAS**, to be consistent with City Policy regarding “part-time” employees, the City Council desires to add to “part-time” employees to SMC 2.90.010 to be included as “officials and employees”; and

**WHEREAS**, The City Council adopted by Ordinances 1881 and 1891 codified as SMC Chapter 2.14, titled “Design Review Board”, which authorizes, establishes and governs the City of Snohomish Design Review Board; and

**WHEREAS**, The City Council adopted by Ordinance 1830 codified as SMC chapter 2.90 titled “Legal Action Against City Officials, Employees and Volunteers”; and

**WHEREAS**, to be consistent with City Policy regarding “Volunteers”, and to accurately reference the code section codifying the Design Review Board, the City Council desires to delete the reference to former Chapter 21.39 and to add Chapter 2.14 relating to the Design Review Board, to the definition of “Volunteers” in SMC Chapter 2.90.010.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SNOHOMISH,  
WASHINGTON, DO HEREBY ORDAIN AS FOLLOWS:**

**Section 1.** Snohomish Municipal Code section 2.90.010 is hereby amended to read as follows.

**2.90.010 Definitions.** As used in this chapter, the following definition shall apply:

“Officials and employees” means all present or former elected City officials, including the Mayor and members of the City Council, together with the City Manager, the City Attorney, the Director of Public Works, the City Clerk, the Police Chief, and all full-time and part-time employees of the City.

“Volunteers” means all present or former duly appointed members of the boards and commissions listed in SMC Chapters 2.12, 2.14, 2.16, 2.18, 2.19, 2.20, 2.22, 19.04, and part-time or reserve officers of the Snohomish Police Department. (Ord. 1830, 1997)

**Section 2.** Except as provided herein, all other provisions of SMC 2.90.010 and Ordinance

1830 remain in place and shall be unchanged by this ordinance.

**Section 3.** Effective Date.

This Ordinance shall be effective five days after adoption and publication and, Pursuant to RCW 35A.13.200, may be published in summary fashion.
