4. APPROVAL OF AGENDA ORDER

7. DISCUSSION ITEM

HOUSING ASSESSMENT & GAP ANALYSIS (HAGA)

Ms. Eidem presented a summary of the HAGA and answered questions from the Planning Commission. There were several questions that Ms. Eidem will follow up on.

The next step in the process is a joint meeting with the City Council on February 21st. The main topic of discussion will be housing, and guest speakers from the Alliance for Housing Affordability and the Department of Commerce will be present to answer questions and provide policy suggestions.

Chair Lippincott asked for a definition of middle housing. Ms. Eidem explained that it is a type of multiple-unit residential development that fits within the context of single-family neighborhoods, generally including duplexes, triplexes, fourplexes, townhomes and cottage housing.

Ms. Eidem asked the Planning Commission to send any additional questions to her in order to allow staff and guest speakers to be prepared to provide answers at the upcoming joint meeting. Commissioner Wakefield Nichols asked about the middle housing grant the City was awarded and Ms. Eidem explained its intent and that it is to support the new requirements of the housing element in the comprehensive plan periodic update.

8. COMMISSIONER QUESTIONS & COMMENTS

Commissioners had no further questions.

9. DIRECTOR'S REPORT

Ms. Eidem provided the Planning Commission's revised 2023 work plan and remarked on the changes made to it. The February 1st Planning Commission regular meeting will be canceled because the Commission will be meeting with the City Council on February 21st at 6 pm. She noted the Planning Commission by-laws will also be adopted at the joint meeting.
