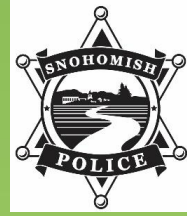

Chief Flood Graduates from the Northwestern University Command College

Chief John Flood, along with 23 members of local law enforcement agencies, recently graduated from Northwestern University's School of Police and Command Staff. The intensive ten week program prepares law enforcement managers for senior positions.

The 400-hour training program included everything from budgeting to leadership to statistical analysis to organizational behavior. The training took place at the Washington State Criminal Justice Training Commission in Brien, with the first day of training occurring on August 1, and graduation on October 21, 2016. The keynote

speaker at graduation was David Rose with Q13 Washington's Most Wanted. Students were challenged to think outside of their comfort level through research of various professional law enforcement topics and to question common practices to ensure a solid foundational understanding of important public safety concepts. Students were also allowed time to share experiences from their respective agencies to compare law enforcement practices being used in the Puget Sound region.

In addition to the educational requirement of the course, the class was asked to come up with a legacy gift for the community. The class chose to help a woman who has three children with heart defects, and was able to raise \$5,000 for the family to assist them with medical expenses and some basic housing needs. Additionally, the class was able to work with a local mechanic to evaluate and repair the older van the woman was using to transport her children to the hospital for treatment. The van had numerous safety problems and the repair shop donated all of the needed parts and labor to help make the vehicle safe. The class also raised and donated \$500 to Special Olympics to help support their worthwhile cause.
