

Grant Awards for 2017 Pavement Overlays

The Washington State Transportation Improvement Board (TIB) has awarded the City of Snohomish a \$504,271 grant for the paving of two City arterial streets in 2017. The City was awarded funds from the Arterial Preservation Program to perform pavement overlays at two streets, Lincoln Avenue (Second Street to the southern City Limits) and First Street (Cedar Avenue to Lincoln Avenue). The TIB grant award will fund just over 75% of the project cost. Local Transportation Benefit District (TBD) dollars were leveraged to meet the agency's required match portion. The City also submitted for the Urban Arterial Program but that grant application was unsuccessful. The application was submitted for improvements to the Bickford Avenue and Weaver Road intersection (either a traffic signal or roundabout), but was not selected.



The City has been very active in seeking both state and federal transportation grant opportunities and has been quite fortunate in recent years. We will continue to work hard and hopefully continue the success which we have had towards capitalizing on future funding opportunities.

Both pavement overlay projects will begin next summer. Please stay tuned for future project updates.

Naming Our City Parks

The City of Snohomish Parks Naming Committee is requesting your help in their research for names of City park facilities. They would like to learn from you and hope you participate* in naming the following properties by January 16, 2017:

- 1. 11 Lincoln Avenue, current placeholder name '20 Acre Park'
- 2. 2000 Ludwig Road, current placeholder name: '2000 Ludwig'
- 3. 1103 Maple Avenue, current placeholder name: '1103 Maple'
- 4. Block located between Second and Third Streets and Pine Avenue and Centennial Trail, current placeholder names: Averill Youth Complex, Hal Moe Pool Site, Tillicum Kiwanis playground, Snohomish Skate Park, Averill Field, and Snohomish Boys and Girls Club.
- 5. Unaddressed Lake Avenue property, current placeholder names: Harryman's Farm, Harryman's Farm Park. Property to be named after the Harryman family using a name such as Harryman Park, Harryman Farm Park, or Harrymans Farm.

*HOW TO PARTICIPATE

1. Provide name suggestions which conforms to any one of the following criteria. Please provide photos or documents to support your suggestion such as letters, newspaper articles, book citations, etc.

As a guideline, examples of name suggestion formats follow the criteria here:

- Criteria One: Names unique to the neighborhood and community. Example: Exclude names already in use such as Pilchuck, Snohomish, Morgantown etc.
- Criteria Two: A natural or geological feature. Example: I recommend ______ (a park facility from list above) be named '______ ' (suggested name of natural or geologic feature) because of the _____ (natural or geologic feature). Attached please find photos or documents showing this feature.
- Criteria Three: Names of historical or cultural significance for the community. Example: I recommend the (a park facility from list above) be named ' (suggested name) because the (historic or culturally significant feature) and here attached is additional information. See attached.
- Criteria Four: A historical figure; or individual (deceased for three years minimum) who has made a significant contribution to the City; or gave their life serving the United States of America in military service.

Example: I recommend the ______ (a park facility from list above) property be named "______' (suggested name) because it was home to ______ (historic figure or individual here) and here attached is the document describing him or her. See attached.

- 2. Email your suggested name(s) and documentation to Denise Johns, City of Snohomish Project Manager at johns@snohomishwa.gov.
- 3. Please note your naming suggestions and supporting documents will become public record and will be posted on the City's website.

The Naming Committee will convene in February to review your suggestions, supporting documents, and other background research. Upon completion of their research, the Committee will make recommendations to City Council, who has the authority to designate names.

Make Sure First Responders Can See Your Address

Having address numbers that are clearly visible and readable from the street is important for residences and businesses alike to ensure a prompt response from police and fire when emergencies occur. It's so important the building code establishes standards for address numbers. For instance, the code states addresses must be installed on all buildings and be clearly visible and legible from the street fronting the property. In residential areas each number or letter must be at least 6 inches high and must be at least one-half inch thick. In commercial areas the numbers must be at least 12 inches high. Also, the numbers must be a color that contrasts with the background on which they are placed.

To promote address readability, Snohomish County Fire District 4 has a program where they provide supplemental reflective address numbers for houses. Reflective numbers shine at night by reflecting off the headlights of oncoming vehicles so they're readable even on the darkest and rainiest nights. While there is a charge for obtaining the numbers the District will put them on a marker plate for easy installation. Or, residents can also request the District install the markers for them.
